(hereinafter referred as Povai) is also in the similar business of manufacturing and selling upholstery fabrics from the year 1990 in Gandhinagar, Gujarat. In the year 2017, The Somani created one of its kind fabric prints in the upholstery fabrics with the artistic patterns of peacock feathers. In the year 2018, The Povai came out with the prints on its fabrics same as of the prints of the fabrics of The Somani. This leads Somani to allege copyright infringement and passing off against Povai. The Povai counters that the works of 'Somani' are not artistic works worthy of copyright protection, but rather designs it ought to have registered under the Designs Act 2000. – Decide with the help of leading judgments by dealing with the concept of Overlap between Copyright and Design regimes in India.
